Meeting Summary

Meeting Purpose

The primary goal of this meeting was to plan for 2020 SNCC, SNCC MD, & SNCC Joint meetings - finalize dates and brainstorm meeting topics.

Partner Introductions & Announcements

- **DataShare Santa Cruz County: SNCC Data Preview**
 - Dorian Seamster, HIP Consultant, presented SNCC data uploaded to www.datasharescc.org. She requested feedback from meeting attendees and permission to make the data live to the public.
 - The group agreed to publicize the data, but requested a password protected version of the page beforehand (in the follow-up email).
- **Census 2020**
 - Tory Del Favero, Partnership Specialist at the U.S. Census Bureau, and Joseph Watkins, Assistant Project Director, presented information about the 2020 Census.
 - They reiterated that the Census can and should be completed by all people living in Santa Cruz County, regardless of citizenship or housing situation (e.g. available to people experiencing homelessness). It can be completed online, over the phone, by mail, or in person. The Census is confidential and available in 13 languages.
- **Fluoride Varnish**
 - Sepideh Taghvaei, DDS, Chief Dental Officer at Dientes Community Dental, and Primavera Hernandez, MPH, Senior Health Educator at the County of Santa Cruz, presented county statistics on fluoride varnish and the importance of applying it at medical well-child visits.
 - The County of Santa Cruz Oral Health program has funds to purchase fluoride varnish for the County. Contact Prima at Primavera.Hernandez@santacruzcounty.us to receive fluoride varnish for your organization and/or staff training about how to apply fluoride varnish.
- **The Whole Child Model**
 - Dave Kramer-Urner, PT, Senior Health Services Manager at Santa Cruz California Children's Services (CCS), and Melanie Rager, Care Management Director at Central California Alliance for Health, presented the Whole Child Model and how CCS is still active and how it has been integrated into the Whole Child Model. Here is an overview, from their presentation, of how both programs work together to cover care for children of vulnerable populations:

ALLIANCE	COUNTY CCS
Oversees care for CCS-eligible conditions for Alliance members (including authorization, case management support, provider network, and claims payment)	Oversees care for CCS-eligible conditions for non-Alliance members .
Identifies children with potential-CCS eligibility and refers to County CCS	Determines CCS program eligibility
Coordinates with the MTP to authorize DME and therapy services.	Administers the Medical Therapy Program (MTP)

- Meeting attendees are asked to continue to identify potential CCS-eligible conditions - refer those people to County CCS and refer any members who would benefit from case management support to the Alliance.
- **The 22nd Annual Jon E. Nadherny / Calciano Memorial Youth Symposium**
 - Jennifer Hastings, HIP Consultant and Co-Medical Director at Encompass Community Services, invited attendees to RSVP for the 2020 Calciano on February 28, 2020 at Cocoanut Grove, Santa Cruz.

SNCC & SNCC MD 2020 Discussion and Planning

- ***Save the Dates: SNCC 2020 Dates*** Holly Hughes, LCSW, HIP Consultant, reviewed proposed SNCC, SNCC MD, and Joint meeting dates for 2020. No attendees objected to these dates, therefore Holly confirmed that these save-the-dates will be sent out as calendar invitations.
- ***Population Health: Group Activity*** Holly asked meeting attendees to brainstorm relevant topics for 2020 SNCC/MD meetings. She instructed people to write topics, frameworks, assessments, and/or speakers on the sticky notes that relate to the different vulnerable populations (e.g. elderly, parents, adolescents). Then, place the sticky notes on the larger posters listing broader population groups located around the room. The SNCC team will review these ideas to plan 2020 meeting agendas.
- ***Spreading the Knowledge*** Holly asked attendees to get into small groups to discuss what HIP can do to improve how we share information and resources among coalition members with regards to SNCC content.
